This is a legally binding release, waiver, and assumption of risk made by me (person), as completed on the registration form to Lions of the Lamb and its members. ### ***INFORMATION WE MAY COLLECT FROM YOU***

We may collect and process the following data about you:

- Information that you provide by filling in the registration form or fields made available on our website [www.lionsofthelamb.com](http://www.lionsofthelamb.com) (**our site**). This includes information provided at the time of registering to our site, subscribing to our newsletter, posting material or requesting further information. We may also ask you for information when you report a problem with our site.
